

CIRCULAR

Bal Bharati Public School focuses on imparting value-based quality education along with experiential learning. We promote the holistic development of our students in which you, as a Parent, have been playing a pivotal role, helping the School to achieve greater heights of success. The School carries forth the legacy and reputation of educational excellence and innovation and has been amongst the top ten schools of the region.

The school did not hike the fee for the session 2020-21 and had charged the same as per the fee structure for the session 2019-20 despite the increase in expenses due to inflation and increase in yearly increments of the staff, dearness allowance etc.

The bills raised by the school in year 2020-21 for charging Development Fee and Annual charges were kept in abeyance because of circulars dated 18 April 2020 and 28 August 2020 issued by the Director of education.

As per the judgment passed by Hon'ble High Court of Delhi in WP (C) No.7526/2020 titled '*Action Committee Unaided Recognized Private Schools Vs Directorate of Education*' on 31.05.2021, the schools have been allowed to collect Development Fee and Annual Charges, at the rates charged in the session 2019-2020. The collection of Development Fee and Annual Charges for sessions 2020-21 and 2021-22 can be made in 6 equal monthly installments starting from 10.07.2021, with a 15% reduction (in Annual Charges and Development Fee only).

The decision of 10 % hiked fee for the year 2021-22 as conveyed to the parents through circular dated 01.05.2021 has been reviewed and deferred by the Managing Committee in light of interim order/s given by the Hon'ble High court of Delhi till its further order/s. Till then, the tuition fee for 2021-22 will be charged at the rates applicable for 2019-20.

Accordingly, the excess amount paid by parents for the first quarter of 2021-22 is being adjusted in Q II. The fee bill after making the above-mentioned changes for Q-II will be made available to you by 07.08.2021. You are requested to make the payments accordingly. The option to pay fees on monthly basis shall be available as usual.
