We are gearing up to welcome the new entrants at Bal Bharati Public School Rohini sector-25 for the session 2022-23. To facilitate safe & smooth commuting of tiny tots to school campus at sector-25, the bus routes for the Pre School students will be finalised on 18 & 19 April 2022.

Kindly note the following -

• IN CASE YOU WISH TO AVAIL THE SCHOOL TRANSPORT SERVICE-

One of the parent /authorised guardian should report at 9:00 am at BBPS Rohini, Sector-25. The parent/authorised guardian will be allowed to board the bus to identify & confirm the bus stop. The same will be put on record by school teachers who will be travelling with the parents in the bus routes.

• IF YOU WISH TO AVAIL CAB/ TAXI SERVICES RUN PRIVATELY-

One of the parent/authorised guardian should report to BBPS Rohini, Sector - 14 from 12 noon to 12:30 pm. The parent/authorised guardian is requested to report along with the van driver in person and submit the required documents attached herewith to the respective class teacher.

IN CASE YOU WISH TO PICK & DROP THE CHILD YOURSELF-

The parent /authorised guardian should report at 1:15 pm to BBPS Rohini, sector-14 to collect the parent/authorised guardian card. The child will be handed over only after the issued card is shown to the class teacher.

You are requested to note that since teachers will be busy with parents in chalking out the transport strategies, school shall remain closed for the students of class Pre School on 18 & 19 April 2022. **You are requested not to bring your ward along with you.**

Note:- For self/ bus users, in case parents are not coming to pick up the child, you are required to submit an authority letter authorising the guardian or escort to pick up your child on your behalf.
